**Donation of COVID-19 Vaccination Support Funds**  
**to the Governments of ASEAN Countries**

As part of its efforts aimed to end the COVID-19 pandemic and ensure “safety and security” in the local communities, Aeon will make a total donation of 350 million yen as support funds to promote vaccination for COVID-19 to the governments of ASEAN countries, namely Malaysia, Vietnam, Indonesia, Thailand, and Cambodia.

Aeon is engaged in the retail, financial services, and services businesses with an aim to contribute to enriching the lives of the people in ASEAN countries and their sustainable development. Restrictions on people’s movements and slowdown in economic activities have continued in ASEAN countries affected by the spread of COVID-19, and the purpose of the donation is to use the funds to facilitate COVID-19 vaccinations being promoted by the ASEAN governments and thereby help take measures against disease control and recover the economy.

The funds include contributions of 100 million yen from Aeon Co., Ltd., and 60 million yen each from Aeon Mall Co., Ltd., Aeon Financial Services Co., Ltd., and Aeon Delight Co., Ltd. developing business in ASEAN countries, and 70 million yen from Aeon 1% Club Foundation.

Based on the Aeon Basic Principles of “Pursuing peace, respecting humanity, and contributing to local communities, always with the customer’s point of view as its core,” Aeon will continue making collective Group efforts to end the COVID-19 pandemic as soon as possible and restore security and peace in the daily lives of local communities.
